Privacy Policy

This Privacy Policy is incorporated into and is subject to our terms of service and applies to the Apps (Android) developed for the Parichay Sammelan of SJMVSS (Technical Support – Rishte Dhage). The use of the App and any personal information provided by user on this app remains subject to the terms of this Privacy Policy. It shall be noted that any status submissions or other content posted at the direction or discretion of users of this App's service becomes published content and is not considered personally identifiable information subject to this Privacy Policy.

What does this privacy policy cover?

This Privacy Policy covers the treatment of user information, including personally identifying information, obtained by us, including information obtained when you register for Parichay Sammelan.

This Privacy Policy does not apply to the practices of companies that we do not own or control, or to individuals whom we do not employ or manage, including any of the third parties to which we may disclose user information as set forth in this Privacy Policy, the information we collect.

What personal information do we collect from the people that download our app?

When registering on our app, as appropriate, you may be asked to enter your name, email address, phone number and other details to help you with your experience. We collect information from you when you register to our app.

We may obtain the following types of information from or concerning you or your mobile phone device, which may include information that can be used to identify you as specified below ('Personally Identifying Information'):

We may use the information we collect from you when you register, make a purchase in the following ways:

- To personalize your experience and to allow us to deliver the type of content in which you are most interested.
- To allow us to better service you in responding to your customer service requests.
- Auto fill your email address while registering to App.
- Device's identity.

What information we do not collect?

We do not collect names, email addresses or other contact information from users' mobile address book or contact lists other than mobile phone numbers. Our mobile application will associate whatever name the user has assigned to the mobile telephone number in his/her mobile address book or contact list and this occurs dynamically on the mobile device itself and not on our servers and is not transmitted to us. The contents of messages that have been delivered by us are not copied, kept or archived by us in the normal course of business. Our Service is meant to be a SMS replacement, using data service through a user's phone (either via cell network or wifi). Users type their messages, which are sent via data service to our servers, and routed to the intended recipient (who must also be our user), if that recipient is online.

What way we use information?
